Notification

In exercise of the powers conferred by sub-section (1) of Section 34 of The Right of Children to Free and Compulsory Education Act, 2009, (Central Act No. 39 of 2009) the Governor is pleased to constitute the State Advisory Council as per following composition :-

Chairperson

Hon'ble Education Minister, Govt. of Uttarakhand;

Ex-officio member –

- (1) Secretary, School Education, Govt. of Uttarakhand, (Vice-Chairperson);
- (2) Chairperson, State Commission for Protection of Child Rights, Uttarakhand;
- (3) Secretary, Women Empowerment and Child Development, Uttarakhand;
- (4) Secretary, Health Department, Govt. of Uttarakhand;
- (5) Secretary, Social Welfare Department, Govt. of Uttarakhand;
- (6) Director, Elementary Education, Uttarakhand, Dehradun;
- (7) State Project Director, Uttarakhand Sabhi ke liye Shiksha Parishad (Member Secretary);
- (8) Addl. Director, SCERT, Narendra Nagar (Tehri Garhwal);

Nominated Members

- (1) One member having specialized knowledge in the field of Pre-Primary Education;
- (2) One member having specialized knowledge and experience in the field of Education of Children with special needs;
- (3) One member from NGO's specially working in the field of Elementary Education;
- (4) One member from scheduled Caste /Scheduled Tribe/ Other Backward Classes; having specialized knowledge and practical experience of Elementary Education;

- (5) One member from Minority Community, having specialized knowledge and practical experience of Elementary Education;
- (6) One member having specialized knowledge in the field of Teacher's Education;

Terms of Constituting the State Advisory Council and its function:

- 1- One third of the nominated members of the council shall be female
- 2- Member Secretary of the Council (i.e. State Project Director, SSA,, Uttarakhand) shall be responsible for convening meeting of the State Advisory Council.
- 3- The meetings of the State Advisory Council shall be convened in every three months and Council shall review the implementation of the provisions of the 'The Right of Children to Free and Compulsory Education Act, 2009' and 'The Uttarakhand Right of Children to Free and Compulsory Education Rules. 2011' as notified by State Government.
- 4- The functions of the State Advisory Council shall be advise The State Government on effective implementation of the provisions of the 'The Right of Children to Free and Compulsory Education Act. 2009'.
- 5- The presence of at least one third of the members shall be deemed full corum.
- 6- The Council shall be re-organized on every year.
- 7- The nominated members of the council shall get traveling allowance/ honorarium as per notified by the State Government from time-to-time.
