

Record of discussion of the Meeting Chaired by Ms. Radha Chauhan , Joint Secretary SE-I on 16th January, 2012 to discuss the formulation of Core Scope Document for the MMP in School Education, under National e-Governance Plan (NeGP).

1. A meeting was chaired by Ms. Radha Chauhan, Joint Secretary (SE I) on 16th January 2012 to discuss the formulation of Core Scope Document for the Mission Mode Programme in School Education. The list of participants is enclosed.
2. At the outset the background of the issue was explained as MMP in School Education has been included as one of the MMPs under NeGP and as a first step in this direction it was proposed to formulate Core Scope Document with the help of National Institute of Smart Governance (NISG). It was also explained that so far two meetings were held to facilitate NISG to make a presentation before the Department as also to facilitate NISG to interact with NEUPA and NCERT.
3. The participants in the meeting have agreed to the fact that better service delivery to the stakeholders apart from creating a platform to develop good and filtered curriculum based e-content are the broad areas to be explored for incorporation in the Core Scope Document. Chairman, CBSE opined that the available content may be reviewed for its accuracy prior to actual usage instead of duplicating the efforts in creating content which is already available. Chairman, CBSE suggested to incorporate the component of artificial intelligence of the student also apart from general capability with a provision for feedback. Simultaneously it was suggested to identify hard topics to give priority in developing e-content. Addl. Commissioner, KVS shared the fact that they have developed mechanism for child tracking and have online disbursement of salaries of teachers and linked the achievements of teachers. Joint Commissioner, NVS shared the fact that they have mechanism for online payments and are utilising mobile technology also.
4. It was suggested that providing country-wide IDs for teachers, students, schools and developing central depository with authentic data can facilitate sharing of best/ innovative practices among the communities concerned which can be explored.
5. JS(SE-I) desired that a mini-group for MMP may be formed to facilitate sharing of information/ views/ communications. Further JS(SE I) also desired that one national level workshop at Delhi and three other Workshops in States preferably in Madhya Pradesh, Kerala and Gujarat could be held.
6. The meeting ended with a vote of thanks to the chair.
