



  - Provision of broadband connectivity.
  - The emphasis should be given to enhance hardware courses in electronic and electrical disciplines.
  - An undertaking to be given by the State Governments that there is no Government Polytechnic in the district in which the new polytechnic is proposed to be established.
  - The admissions in these polytechnics shall be made by the respective State Governments alongwith the other polytechnics of the States as per admission procedure criteria, reservation norms and guidelines followed.
  - At the end of the financial year State Government shall have the accounts in respect of grants received from the Government of India audited through the concerned AG and submit audited statement of accounts to the Ministry of Human Resource Development promptly along with the statement of physical achievements made during the year. The grants in aid in the subsequent years shall be released on receipt of the audited statement of accounts along with the progress report of the physical achievements. The State Government shall utilize the grants within twelve months of the date of sanction.
  - The accounts of the grantee shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under provision of CAG (DPC) Act 1971 and Internal Audit by the Principal Accounts Office of the Ministry of Human Resource Development, Deptt. of Higher Education, whenever the grantee is called upon to do so.




