An amount of Rs. 7.125 crores to the under mentioned district vide aforementioned Sanction orders for setting up polytechnic in the District mentioned below has already been released.

Now, I am directed to convey the sanction of the President of India to the payment of **Rs. 2,34,00,000/- (Rupees Two crore thirty four Lakhs only)** as another installment to the Secretary dealing with Technical Education, **State Government of Tripura** as per the details given below for incurring expenditure on Setting up of new polytechnics in these Districts :-
