### RESOLUTION

The Central Advisory Board of Education (CABE), the highest advisory body to advise the Central and State Governments in the field of education, was first established in 1920. It was dissolved in 1923 as a measure of economy and was again revived in 1935. It continued to be in existence till 1994. Since important decisions have been taken on the advice of CABE and it has provided a forum for widespread consultation and examination of issues relating to educational and cultural development, CABE was reconstituted on 12<sup>th</sup> December, 2008 for a period of three years and subsequently on 18<sup>th</sup> May, 2012. The tenure of the CABE has since expired on 17<sup>th</sup> May, 2015. CABE has an important role to play at the present times, particularly in view of the significant socio-economic and socio-cultural developments taking place in the country as also the wide ranging reforms taking place in the education sector. It is, therefore, desirable that the Central and State Governments, educationists and people representing different interests should evolve a participative process of decision making in education which enhances the federal structure of our polity.

- 2. The Government of India has accordingly decided to reconstitute CABE. A list of members of CABE is placed at Annexure I.
- 3. The functions of CABE shall be:
  - a) To review the progress of education from time to time;
  - b) To appraise the extent and manner in which the National Policy on Education has been implemented by the Central and State Governments, and other concerned agencies, and to give appropriate advice in the matter;
  - c) To advise regarding coordination between the Central and State Governments/ UT Administrations, State Governments and Non-Governmental Agencies for development of education in accordance with the National Policy on Education;
  - d) To advise, suo-moto, or on a reference made to it by the Central Government or any State Government or a Union Territory Administration on any Educational question; and
  - e) To review the National Policy on Education.

## 4. For the discharge of these functions, the Board may:

- (i) Call for information and comments from any government institution, any other organisation or an individual;
- (ii) Appoint committees or groups comprising members of CABE and/or others as may be necessary;
  and
- (iii) Commission through Government or any other agency, studies, research or reports on any specific issue requiring the attention of the Board or its Committees or groups.

## 5. (a) TENURE:

The tenure of CABE shall be three years, with effect from the date of Notification of this Resolution.

## (b) CASUAL VACANCIES:

- (i) All casual vacancies among the members, other than ex-officio members shall be filled by the Authority or body which nominated or elected the members whose place falls vacant.
- (ii) The person nominated or elected to a casual vacancy shall be a member of the Board for the residue of the term for which the member whose place he fills would have been a member.

## (c) MEETING:

The Board will meet at least twice every year and there shall not be a gap of more than one year between two consecutive meetings of the Board.

### (d) AGENDA:

- (i) The Agenda, the explanatory Memorandum and the Record of proceedings/Minutes of the meeting shall be prepared and circulated by the Ministry of Human Resource Development (Department of Higher Education), Government of India
- (ii) The Agenda and the explanatory Memorandum will ordinarily be circulated to all the members at least 10 days before the date of the meeting of the Board.

## (e) QUORUM:

The quorum of the meeting of the Board shall be  $2/3^{rd}$  of the total membership of the Board.

## (f) PROCEDURE:

The Board will adopt its own procedures in respect of matters not provided for above.

## (g) GENERAL:

No proceedings of the Board shall be invalid merely on the ground of procedural defect or vacancy under any category of membership.
