I am directed to say that the Government of China has provisionally awarded you a scholarship to undertake studies in China. The brief details and terms and conditions of the scholarship are as under:-

- a) Your admission details as per the list attached.
- b) Government of India will bear the International passage cost from India to China and back. Candidates are required to inform Indian Mission in China at least prior to two months from likely date of completion of study and the date of departure from China so that the arrangement for tickets could be made well in advanced.
- c) The scholarship will be paid by the Govt. of China at admissible rates. The Govt. of India will also pay a supplementary stipend of Yuans 1170 per month.
- d) You are required to execute a Bond in duplicate with this Ministry and agree to abide by the terms and conditions of the Bond.
- e) You are required to submit the following:
 - (i) Bond (in duplicate) (Annex-I),
 - (ii) Certificate of Solvency (in duplicate) (Annex-II),
 - (iii) Declaration by Sureties (in duplicate) (Annex-III),
 - (iv) Declaration by the Scholar (Annex-IV)
 - (iv) Physical Examination Form issued by any Government Hospital (Annex-V),
 - (v) Employer's undertaking (if employed) (Annex-VI)
 - (vi) 3 passport size photographs,
- f) You are expected to be in good health and meet the physical requirements as prescribed by the Government of China. If you are found falling short of health requirements, the Chinese Universities will not admit you.
- g) You will have to abide by the regulations issued by the Chinese authorities governing foreign students admitted in Chinese Universities.
- h) You are required to carry all original educational certificates for proof of age and qualification etc.
- i) On your return to India after completion of your studies, you have to submit a final report regarding your studies in China.

2. You are advised to intimate your acceptance of the offer. If you accept the offer, you are advised to arrange your passport immediately as you are required to reach China positively by, **the date of registration deadline**. You are required to submit the bond and other documents complete in all respect to this Ministry latest by **17th August 2015** positively. After completion of formalities and acceptance of bond the letter for visa clearance, admission notice and air ticket will be issued to you by this Ministry.
3. You are directed to submit photocopies of Visa issued by Chinese Embassy at New Delhi and your travel plan for final clearance by the Ministry about one week before your departure to China, failing which the action for bond violation penalty will be taken against you without further notice.
4. You are required to report to the Embassy of India, Beijing (Address *No.5,Liang Ma Qiao Bei Jie, Chayoyang District, Beijing – 100600 Tel. No. 00-86-10-85312512. /Consulate General of India, 1008 Shanghai International Trade Centre, 2201 Yan An West Road, Shanghai. – 200336, Tel: 62758882/5&6. Extn.21*). On your arrival in China, you have to submit the joining report to the Indian Embassy/CGI Shanghai in the enclosed Performa. You are requested to route your correspondence with this Ministry through the Indian Mission there. No direct request of any kind will be entertained. In case of any difficulty, you are advised to seek the help of Indian Mission there.
5. You are advised to carry some amount in hard currency, which you may require for personal expenses during your journey and at the initial stage in China.
6. You should not accept any employment in any of the Chinese /Indian Institution in china without prior permission of this Ministry.
7. It has been observed that people in foreign countries are eager to know a lot about Indian Culture, History, Philosophy, Administration, Education, and Economics Development etc. You are advised to gather correct information and knowledge on the above topics.
8. On return to India after completion of study, please report to this Ministry (ES.3 Section) and submit the final report about your study in the prescribed Performa and photocopies of the degree/diploma obtained in China, otherwise it will be treated as willful violation of the terms and conditions of the Bond and action will be initiated to recover the bond money from you or your sureties.
