- 2. As per information available, 21 States Arunachal Pradesh, Assam, Bihar, Himachal Pradesh, Jammu and Kashmir, Jharkhand, Kerala, Maharashtra, Manipur, Meghalaya, Mizoram, Nagaland, Orissa, Punjab, Rajasthan, Sikkim, Tamil Nadu, Tripura, Uttarakhand, Uttar Pradesh and West Bengal) are using the NIC platform for procurement under the PMGSY Scheme. In addition, NCT of Delhi, Chandigarh UT, Haryana, in addition to other States are using GePNIC, for e-procurement.
