I am directed to say that it has been decided to fill up the post of Assistant Director (Official Language) in the pay band of Rs.15600-39100 with grade of Rs.5400 in the Directorate of Adult Education, a Subordinate Office under the Department of School Education & Literacy on deputation [including short term contract] plus promotion from the:-

Officers of Central Government/State Governments or Union territories or Universities or recognized research Institutions or public sector undertakings or semi Government or Autonomous or Statutory organizations;-

- (a)(i) holding analogous post on regular basis in the parent cadre or department; or
- (ii) with two years' service in the grade rendered after appointment thereto on a regular basis in the pay band-2, Rs.9300-34800/- with grade pay of Rs.4800 or equivalent in the parent cadre or department; or
- (iii) with three years' service in the grade rendered after appointment thereto on a regular basis in the pay band-2, Rs.9300-34800/- with grade pay of Rs.4600 or equivalent in the parent cadre or department; or
- (iv) with eight years' service in the grade rendered after appointment thereto on a regular basis in the pay band-2, Rs.9300-34800 with grade pay of Rs.4200/- or equivalent in the parent cadre or department; and
- (b) possessing the following educational qualifications and experience:

#### Essential

(i) Master's degree of a recognized University in Hindi with English as compulsory or elective subject or as the medium of examination at the degree level; or

Master's degree of a recognised University in English with Hindi as a compulsory or elective subject or as the medium of examination at the degree level; or

Master's degree of a recognized University in any subject other than Hindi or English with Hindi medium and English as a compulsory or elective subject or as the medium of examination at the degree level; or Master's degree of a recognized University in any subject other than Hindi or English with English medium and Hindi as a compulsory or elective subject or as a medium of examination at the degree level; or

Master's degree of a recognized University in any subject other than Hindi or English with Hindi as compulsory or elective subject or either of the two as a medium of examination and the other as a compulsory or elective subject at the degree level.

(ii)Three years' experience of using or applying terminology (terminological work) in Hindi and translation work from English to Hindi or vice-versa, preferably of technical or scientific literature under the Central Government or State Governments or Autonomous Bodies or Statutory organization or public sector undertakings or universities recognised or educational Institutions.

Or

Three years' experience of teaching in Hindi and English or research in Hindi or English under the Central Government or State Governments or Autonomous Bodies or Statutory organisation or public sector undertakings or universities or recognised research or educational Institutions.

### Desirable:

Studied one of the languages other than Hindi included in the Eighth Schedule to the Constitution at the 10th level from a recognised Board.

The departmental Junior Translator in the pay band-2, Rs.9300-34800 with grade pay of Rs.4200/-with eight years' regular service in the grade shall also be considered along with outsides candidates and in case he is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

The period of deputation (including short term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarly not to exceed three years.

The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding 56 years as on the closing date of the receipt of applications.

For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1<sup>st</sup> January, 2006 or the date from which the revised pay structure based on the recommendations of the Sixth Central Pay Commission has been extended shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the said Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extended only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation

## Brief Duty of the post:

The Assistant Director (Official Language) in the Directorate of Adult Education is overall responsible of work relating to Hindi Translation and, Implementation of the instructions, orders and decision of Official Language and its Committee, in the Directorate, also the Member Secretary of the Departmental Official Committee, nominated member of the Directorate for training under Hindi Teaching Scheme of the Department of Official Language and he is also responsible to see that the returns and reports should reached to the Department of Official Language of the Ministry of Home Affairs.
