ORDER

Subject:- Joint Seat Allocation process for admissions to the Centrally Funded Technical Institutions (CFTIs) - reconstitution of Joint Seat Allocation Authority (JoSAA) - regarding.

To look into the process flow differences between the Indian Institutes of Technology (IITs) and National Institutes of Technology (NITs) counseling, a Technical Committee was constituted under the Chairmanship of Director, IIT-Kharagpur. The Technical Committee had recommended Joint Seat Allocation process from the academic year 2015 - 2016.

2. As per recommendations of the Technical Committee, the Joint Seat Allocation process through Joint Seat Allocation Authority (JoSAA) has been put in place from the academic year 2015 - 2016 onwards.

3. In continuation of this Ministry's Order of even number dated 9th March, 2016, it has been decided to re-constitute Joint Seat Allocation Authority (JoSAA) - 2017 to conduct joint / common counseling smoothly for the academic year 2017 - 2018. The JoSAA - 2017 shall comprise following:-


(i)	Chairman, Joint Admission Board (IITs) - 2017 (Director, IIT - Madras).	Co-Chairman & Convener

(iv)	Chairman, Central Seat Allocation Board (CSAB) - 2016 (Director, NIT - Patna).	Member
(v)	Chairman, Joint Implementation Committee (IITs) - 2017.	Member

4. The JoSAA - 2017 may co-opt Member(s) as it may deem fit for smooth coordination and ensure timely implementation of various aspects of Joint Seat Allocation process as per schedule.

The common / joint counseling will be conducted by JoSAA - 2017 for admission of students to Centrally Funded Technical Institutions (IITs, NITs, IIITs, SPAs & other GFTIs) for the academic year 2017 - 2018. The CSAB (NITs) and JAB (IITs) shall enter into a Memorandum of Understanding (MoU) for Joint Seat Allocation process during 2017 - 2018.
