NOTIFICATION

1. <u>Short title and commencement - (I)</u> These rules may be called the Ministry of Human Resource Development (Department of Higher Education), Copyright Information Officer, Group 'A' Post Recruitment Rules, 2016.

(II) They shall come into force on the date of their Notification in the Official Gazette.

- 2. <u>Application</u>:- These Rules shall apply to the posts mentioned in Column 1 of the Schedule annexed to these rules.
- 3. Number of Post. Classification and Scale of Pay The number of the said post, their classification and the scales of pay attached there to shall be as specified in columns 2 to 4 of the Schedule aforesaid.
- 4. <u>Method of recruitment, age limit, qualifications, etc.</u> The method of recruitment, age limit, qualification and other matters relating to the said post shall be as specified in columns 5 to 13 of the said Schedule.
- 5. <u>Disqualification</u> No person:
  - (a) Who has entered into or contracted a marriage with a person having a spouse living, or
  - (b) Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such persons and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rules.

- 6. <u>Power to relax</u>: Where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order and for reasons to be recorded in writing, and in consultation with Union Public Service Commission relax any of the provisions of the rules with respect to any class or category of persons.
- 7. Saving: Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
