The Director of an IIIT, being the academic as well as administrative head, is expected to have proven administrative, teaching and research background (including significant experience in research guidance at the Ph.D. level) with the leadership qualities to head an Institute of National Importance. The appointment will be on contractual basis for a period of five years or till the attainment of 70 years, whichever is earlier, as per usual terms and conditions.
