Invitation of applications for the post of Directors IIIT (PPP) at Kalyani

Applications are invited, for appointment to the post of Director of Indian Institute of Information Technology in Public- Private Partnership mode (IIIT-PPP) at Kalyani.

2. The Director of an IIIT, being the academic as well as administrative head, is expected to have proven administrative, teaching and research background (including significant experience in research guidance at the Ph.D. level) with the leadership qualities to head an Institute of National Importance. The candidate should be a Ph.D. in appropriate branch with an outstanding academic record throughout and a minimum of 7 years' experience as a Professor in a reputed Educational Institute (relaxable in the case of an outstanding candidate). Candidates with industrial research experience in CS/IT or emerging technologies are also welcome to apply. In case the candidate possesses significant and proven industry experience in the field of CS/IT or emerging technologies, the requirement of significant experience in research guidance at Ph.D. level and of them possessing Ph.D. degree, may be relaxed. Applicant should preferably be not more than 60 years of age. The post carries a fixed pay of Rs. 2,10,000/- (Fixed) as per 7th CPC plus Special Allowance of Rs. 11,250/- per month with allowances as admissible under the Rules of the Institute.

3. IIIT Kalyani is an autonomous institutions established in PPP mode, with participation from the Central Government, the concerned State Government, and the Industry Partner(s). The Director will be appointed after obtaining the approval of the Competent Authority based on the recommendations made by the Search-cum-Selection Committee. The Search-cum-Selection Committee will consider applications received in response to this advertisement, as well as nominations received from eminent persons. The appointment will be on contractual basis for a period of five years or till the attainment of 70 years, whichever is earlier, as per usual terms and conditions.

4. Eligible/interested persons may apply ONLINE in the prescribed application form available at <http://www.education.gov.in> and www.nitcouncil.org.in. Online application window shall remain open from 28.07.2025 to 09.09.2025 upto 11:59 PM. Both dates are inclusive.

5. Candidates are mandatorily required to upload Bachelor's, Master's, Ph.D degrees on the portal before the last date. Candidates are also mandatorily required to upload the No Objection Certificate (NOC) on the recruitment portal by the last date of receiving applications i.e. 09.09.2025 upto 11:59 PM. The NOC should be in the prescribed format only and duly verified by the Head of the Institution/Organisation/present employer.

6. Application once submitted cannot be altered/resubmitted, under any circumstances. Further, no request with respect to making changes in any data/particular entered by the candidate in the Online Application will be entertained, once the application is submitted successfully. Therefore, please keep all data / details ready before you start filling up the Application Online.
