

Minutes of the Selection Committee Meeting held on 10.03.2014 at Copyright Office, MHRD, Jeevan Deep Building, Parliament Street, New Delhi at 02:00 PM onwards for appointment to the position of Legal Assistant on contractual basis In Copyright Office, Ministry of Human Resource Development.

The following members constituted the Selection Committee:-

The Selection Committee was informed that an advertisement for Walk-in-interview was hosted on the websites of EdCIL, Copyright Office and MHRD on 03-03-2014 inviting applications for the post of Legal Assistant on contractual basis for Copyright Division, MHRD. Total 87 no. of candidates who were meeting the minimum eligibility criteria registered their candidature as per the attendance sheet at (Annexure-I). However, nine candidates at SI No. 07, 18, 36, 47, 53, 71, 77, 79 and 82 did not appear before the Selection Committee.

It was decided by the Selection Committee to assess the suitability of the candidates on the following parameters:-
