- 1. The candidate should be of Indian origin and possess the highest level of competence, integrity, morals, ethics and strong commitment to the institution.
- 2. The person to be appointed as a Vice-Chancellor should be a distinguished academician, with a minimum of ten years' of experience as Professor in a University or ten years' of experience in a reputed research and /or academic administrative organisation with proof of having demonstrated academic leadership.
- 3. The candidate committed to the principles of Arya Samaj, Gurukul System of Education and Vedic culture.
- 4. The candidate should not exceed 65 years of age as on the closing date of receipt of applications of this advertisement.

# Salary and Service Conditions:

- 1. The Vice-Chancellor shall be a whole-time salaried officer of the Institute. The post carries a pay of Rs. 2,10,000/- (fixed) per month with special pay of Rs. 11,250/- and other usual allowances.
