NOTIFICATION

No. 9-15/2001-U.3(A): Whereas, Section 3 of the University Grants Commission (UGC) Act, 1956 provides inter - alia that the Central Government may, on the advice of the Commission, declare by notification in the Official Gazette, that any Institution for higher education, other than a University, shall be deemed to be a University for purpose of the said Act.

2. **And whereas,** in exercise of the powers conferred by Section 3 of the UGC Act, 1956, the Central Government, vide Notification No.9-15/2001-U.3 dated 24.05.2005, on the advice of UGC, had declared Krishna Institute of Medical Sciences, Karad, Satara, Maharashtra as Deemed to be University with immediate effect subject to the conditions that the Institute will adhere to the guidelines/instructions issued by UGC and other concerned statutory bodies from time to time as applicable to the Deemed Universities.

3. **And whereas,** the Registrar, Krishna Institute of Medical Sciences, Karad, Maharashtra submitted its request to rechristen the name of existing 'Krishna Institute of Medical Sciences', Karad, Maharashtra to 'Krishna Vishwa Vidyapeeth', Karad, Maharashtra.

4. **And whereas,** the Government, vide its letter No. 9-15/2001-U.3 dated 23.09.2022, conveyed its in-principle approval for change of the name of 'Krishna Institute of Medical Sciences', Karad, Maharashtra to 'Krishna Vishwa Vidyapeeth', Karad, Maharashtra for fulfilment of the following conditions:

- i. The Deemed to be University shall transfer its Corpus Fund with the new name.
- ii. The Deemed to be University shall register its MoA/Rules with the new name.

5. **And further whereas,** the Institution submitted its compliance report on 07.10.2022 that was sent to UGC for verification and advice. After verification of the compliance report, UGC vide its letter No. 6-18/2004 (CPP-I/DU) dated 17.10.2022 conveyed its no objection for change of name of the said Deemed to be University.

6. **Now, therefore,** in exercise of the powers conferred under Section 3 of the UGC Act, 1956, the Central Government, on the advice of the UGC, do hereby convey its approval for change the name of '**Krishna Institute of Medical Sciences**', Karad, Maharashtra to '**Krishna Vishwa Vidyapeeth**', Karad, Maharashtra with effect from the date of this Notification.

7. It is clarified that Krishna Vishwa Vidyapeeth, Karad, Maharashtra shall not use the word 'University' either in prefix or suffix to its name. In all its advertisements, public notices, communications, etc., the institution deemed-to-be-university shall distinctly mention under its nomenclature by inserting (within brackets) a line, which shall read: "Declared as Deemed-to-be-University' under Section 3 of the UGC Act, 1956.

8. All other conditions mentioned in the earlier Notification(s) of this Ministry as well as the Norms / Regulations of UGC and Statutory Council(s) concerned, issued from time to time, shall continue to be adhered by Krishna Vishwa Vidyapeeth, Karad, Maharashtra.
