**Minutes of the Second meeting of the Central-Grant-in-Aid Committee for the Centrally Sponsored Scheme for Providing Quality Education in Madarasas (SPQEM) and Scheme for Infrastructure Development Private Aided/Unaided Minority Institutes (Elementary Secondary / Senior Secondary Schools) (IDMI) for the year 2015-16 held on 14.01.2016 at 3.00 p.m. under the Chairmanship of Secretary (School Education & Literacy) (List of participants at Annexure-I)**

1. The Second meeting of the Central Grant-in-Aid Committee (CGIAC) for the year 2015-16 for considering proposals under the Scheme for Providing Quality Education in Madarasas (SPQEM) and Scheme for Infrastructure Development of Private Aided/ Unaided Minority Institutes (Elementary Secondary/ Senior Secondary Schools) (IDMI) was held on 14.01.2016 at 3.00 pm under the Chairmanship of Dr. S.C. Khuntia, Secretary, Department of School Education & Literacy. A list of participants is attached at Annexure.
2. Dr. Meenakshi Jolly, Director welcomed the Chairman and all the participants and outlined the steps taken by the Department of School Education and Literacy to familiarize States about the SPQEM and IDMI schemes. She mentioned that a training cum workshop session was organized in New Delhi on 09.10.2015 with the States implementing SPQEM and IDMI to facilitate the smooth and speedy disposal of proposals received under the schemes. At this workshop, the methodology and format for submitting proposals as per the Schematic Guidelines was explained, and the norms of the two schemes were shared. The Department also held a preliminary meeting on 22.12.2015 where all the proposals were discussed and the State representatives were informed about the shortcomings in their proposals, if any, for redressal.
3. Professor Halim Khan, Member of CGIAC mentioned that since all madarasas may not have UDISE (District Information System of Education) Code; a Unique Identity/ Registration code could be given to those which do not have U-DISE Code. For those with U-DISE Code, that code should be used as Identity Code.
4. Chairman, CGIAC observed that madarasas which are schools will have DISE Code, otherwise a Unique Identity/ Registration code has to be mentioned. The madarasas affiliated to the State Madarsa Board could use their Registration/ Identity number. In absence of DISE Code of Madarsa Board registration no., a State specific Unique ID number should be used so as to avoid duplication.

5. He further observed that instead of States sending proposals in several lots, the proposals for the next financial year should be combined in one lot along with the list of madarsas and Unique ID number for each madarsa. He also mentioned that a specific deadline should be specified by the State Government to the madarsas in their State for submission of UCs on time so as to facilitate timely release of funds. It was further emphasized that the State Government should also certify that there is no duplication of proposals and that the proposals should come from the concerned State Government and not directly from the Directorates.

## (2) KERALA

The State Government of Kerala has forwarded the proposal for 547 Madarsas for 4 years from 2011-12 to 2014-15. However, as per the norms of the scheme, the State Government has to claim renewal grant annually. The State Government had informed that the madarsas in Kerala were working only on holidays and were not full time madarsas.

The Committee observed that only full time madarsas can be given necessary grants and those working on holidays and on part time basis cannot be funded under SPQEM. The Committee decided that no further grant can be sanctioned.

**(5) TRIPURA**

The proposal for 129 madarsas for the year 2015-16 was considered by the Committee in the last meeting held on 15.09.2015. The State Government has sought grant for salary of 235 Graduate and 94 Post Graduate/ Graduate with B.Ed. alongwith annual grant for maintenance of Library/ Book Bank for the Madarsa Board. It was observed that number of teachers for the year 2015-16 for whom grant is being sought is higher than the number of teachers of previous years.

Accordingly, the State Government was requested vide this office letter no. 8-22/2015-EE.19 dated 8th September 2015 to forward the list of madarsas alongwith no. of teachers in each madarsas and their educational qualification proposed to be covered under SPQEM scheme during 2015-16 since it was observed that no. of teachers for the year 2015-16 for whom grant is being sought was higher than the no. of teachers of previous year. However, no reply from the State Government was received.

The Committee in the last meeting on 15.09.2015 had therefore, directed that the proposal could be considered after receipt of the above said requisite clarification from the State Government. Moreover, the State Government representative was also not present during the meeting for giving necessary clarification.

A clarification has been received from the State Government and the State Government has clarified that the honorarium for the SPQEM Undergraduate teachers is being paid from the State funds after 2013 as Government of India had stopped funding to provide honorarium to them. The Committee examined and approved the renewal proposal for 129 Madarsas for the year 2015-16 and approved the honorarium of 235 Graduate Teachers and 94 Post Graduate, Graduate with B.Ed. and Post Graduate with B.Ed. teachers, as recommended by the State Government, as detailed below:

The Committee approved the proposal for 23 madarsas for the year 2015-16 for honorarium of 16 Graduates Teachers and 50 Graduate with B.Ed./ Post Graduate teachers, as recommended by the State Government of Uttarakhand, as per details given below:

**(4) KERALA**

The Committee considered the proposal for **828 Madarsa for the year 2014-15** and the same was not agreed to in view of the fact that all the madarsas in the State are functioning on a part time basis and on holidays only and hence do not qualify as per the norms of SPQEM.

**(5) UTTAR PRADESH**

**1506 Madarsa for the year 2015-16**

The Committee observed that it must be certified by the State Government that all these madarsas are new madarsas and there should not be any duplication. The Committee examined and approved the proposal for 1506 madarsas for honorarium of 1808 Graduates Teachers and 2493 Post Graduate, Graduate with B.Ed. and Post Graduate with B.Ed. teachers, as recommended by the Government of Uttar Pradesh, as detailed below:

**(7) ASSAM**

- (i) The proposals for SPQEM and IDMI for the State Government of Assam were received on 23.12.2015. The proposals signed by Dr. K. Ali Ahmed, the Member Secretary, State GIAC Assam cum Madarsa Education, Assam for release of Rs. 35,79,50,000/- for 900 madarasas under Scheme for Providing Quality Education in Madarasas (SPQEM) and Rs.4,68,00,000/- for 9 Institutions under Infrastructure Development Minority Institutions (IDMI) respectively were forwarded by the Member Secretary.

No minutes of any SGIAC meeting were found enclosed. A complaint had been received in the Department of School Education and Literacy wherein it had been mentioned that Director of Madarasas Education, Assam had allegedly performed and completed the exercise of the process of scrutiny of the applications received without constituting the State Selection Committee for the purpose.

- (ii) In view of the above, the proposals were not considered in absence of requisite clarification regarding constitution of any Committee as per Schematic Guidelines. No SGIAC recommendations form for the proposals and no formal communication from Secretary to the Govt. of Assam, Secondary Education Department, has been received. Director, (MJ) Deptt. of School Education & Literacy had also discussed the issue with the Commissioner and Secretary (Secondary Education) to the Government of Assam who had mentioned that no proposal has been sent from the State Government of Assam. Clarification from State Government of Assam is still awaited. No representative from the State of Assam, was present in the CGIAC meeting.

**Agenda 5 Infrastructure Development Private Aided/Unaided Minority Institutes (Elementary Secondary/ Senior Secondary Schools) (IDMI):**

Proposals under IDMI were received from State Government of Arunachal Pradesh, Manipur, Nagaland, Gujarat, Maharashtra, Kerala, Uttarakhand, Sikkim and Mizoram. While examining the proposals, it was noticed that most of the proposals did not include the necessary certificates/documents such as School Registration Certificate, Society Registration Certificate, Minority Status Certificate, signed State GIAC

recommendation form etc. which are mandatory as per IDMI Scheme guidelines, therefore, letters were written to the State Governments to forward the same.

The State -wise details of the proposals are as under:

**(i) ARUNACHAL PRADESH:**

The Central GIAC in the meeting held on 10.03.2015 had directed the State Government representative to give directions to the two institutions to deposit 25% share in their account first.

The State Government representative had informed in the next CGIAC meeting held on 15.09.2015 that the amount has been deposited by the Institutes. The Committee had observed that the minority certificate submitted was from district level. It should be certified by an officer designated for this purpose by the State Government. The case was deferred to the next meeting and it was directed that an appropriate minority certificate should be submitted.

Minority certificate issued by Directorate of Secondary Education, Govt. of Arunachal Pradesh has been received. It has been issued by Director of Secondary Education, Government of Arunachal Pradesh. It is further mentioned in a letter received from the Directorate of Secondary Education that matter regarding issuing of Minority Certificate was taken up with the Department of Social Welfare, Government of Arunachal Pradesh but the Department has not yet formulated the procedure and the same is awaited, which may take time. Therefore, the requisite Certificate has been issued by the Education Department.

No State Government representative was present in the meeting. The proposal was therefore deferred.

**(ii) MANIPUR-** The Government of Manipur had forwarded 1 proposal under IDMI for consideration of Central GIAC which was placed in the previous meeting held on 10<sup>th</sup> March, 2015 of Central GIAC but was deferred in absence of the State Govt. representative.

The CGIAC had observed that the State GIAC recommendation form was not signed by the Secretary of the SGIAC. The Committee deferred the proposal with the direction that the State GIAC recommendation should be submitted again and the proposal should be complete in all respects.

The State representative explained in the meeting that the children enrolment should be read as 1450 instead of 500 and that they have also forwarded a revised statement. A statement indicating Class-wise student's enrolment in the school during academic year 2014-15 duly signed by the concerned Zonal Education Officer and also list of the students indicating the communities furnished by the Vice Principal of the school alongwith the photograph of the institution were handed over at the time of meeting.

The Committee examined the proposals and approved 11 classrooms as per details below:

- (iii) **NAGALAND-** The Government of Nagaland had forwarded 5 proposals under IDMI for consideration of the Central GIAC which were placed in the previous two meetings, dated 10<sup>th</sup> March, 2015 & 15<sup>th</sup> September, 2015 respectively but was deferred in absence of the State Govt. representative in both the meetings. The proposal also lacked certain requisite certificates such as School Registration Certificate, Society Registration Certificate, Minority Status Certificate and signed State GIAC recommendation form, etc.

The requisite documents have not been received from the State Government and no State representative was present. The proposals were therefore not considered.

- (iv) **GUJARAT-** The State Government of Gujarat has forwarded the following 26 proposals under IDMI for consideration of CGIAC. However, most of the documents/Certificates are in Gujarati. The Department had written to the State Government to forward the translation of the certificates. The State representative submitted that the English/ Hindi version of Minority Certificate will be submitted.

The Committee examined and approved the proposals at Sr. No. 6 and Sr. No. 25 subject to submission of English/ Hindi version of Minority Certificates, as per details below:

- (v) **MAHARASHTRA:** - The Government of Maharashtra has forwarded 87 proposals. The CGIAC did not approve the proposals.
- (vi) **KERLA-** The Government of Kerala had forwarded 224 proposals under IDMI for consideration of Central GIAC which were placed in the previous meeting of the Central GIAC held on 15.09.2015 but could not be considered and were deferred in absence of the State Govt. representative. Besides, the State Govt. has forwarded 50 more new proposals for the consideration of CGIAC.

**i) 50 proposals**

Out of 50 proposals, recommendation of State GIAC has been received in respect of 4 proposals.

Out of these four fresh proposals, the other 3 proposals were not justified as per student classroom ratio and only one proposal was justified and the same was approved as per details given below: following proposal is approved as per details below:
