- 2. I am, accordingly, directed to convey the sanction of the President of India to the payment of central assistance (Non-recurring) of Rs. 14,62,500/- (Rs. Fourteen Lakh Sixty Two Thousand and Five Hundred only) as first instalment against the approved cost of the proposal amounting to Rs. 29,25,000/- (75% Central Government share) subject to the condition that the assistance is utilized in a time bound manner and the balance of 50% of the approved Central Government's share will be released within one year of the release of first installment during which period the 25% share of the minority institutions, should be contributed to the infrastructure up gradation. Moreover, release of next installment of central assistance would be subject to furnishing of UCs along with the audited expenditure certificate.
- 3. The expenditure involved is debitable to Demand No.59-Department of School Education and Literacy Major Head '3601 Grants-in-Aid to State Government 02-Grants for Centrally Sponsored Plan Scheme, 165-Elementary Education, 01-The Scheme for Infrastructure Development in Minority Institutions (IDMI) 01.00.35-Grants-in-Aid Capital assets (Plan) 2015-16.
- 4. On receipt of the sanction letter, the Principal Accounts Officer may issue an advice to Reserve Bank of India (Central Accounts Section), Nagpur for affording credit to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and finance Department of State Government concerned along with a copy to the undersigned.
