Minutes of 3rd National Level Review Meeting of Finance Controllers under RMSA

- The 3rd National Review Meeting of Finance Controllers of State Implementing Society of Rashtriya Madhyamik Shiksha Abhiyan was held on 30th July 2012 at Scope Complex, New Delhi.
- The meeting was chaired by Ms. Caralyn Deshmukh, Director, School Education, MHRD, New Delhi.
- 3. Representatives of 25States/ UTs attended the Review meeting cum Workshop. The list of participants is at *Annexure-A*.
- 4. The agenda of the meeting are at *Annexure-B* resp.
- 5. Ms. Caralyn Deshmukh, Director welcomed participants of all States/UTs. Director informed started the discussion of the day with the following issues :
 - 5.1 During 5th January 2012 Education Secretaries' meeting, Secretary, (SE&L), MHRD, has raised the issue of shortage of funds under RMSA when Secretaries of Education from the States mentioned that the States were facing the problem of slow release of funds from MHRD. Director again emphasized the point that RMSA fund allocation is not large; therefore MHRD has not been able to release all committed approval items' funds to the states. She informed that total allocation available to MHRD is Rs.3124 cr out of which RS. 1200cr has been allocated for recurring activities and Rs. 1924 cr for non recurring activities. MHRD had tried to seek some additional funds for RMSA.
 - 5.2 JS(SE-I) had written a letter in May 2012 to all States/ UTs informing that in the year 2012-13, no new non recurring component would be considered under the programme and hence advised the States/ UTs to prepare and submit the Annual Work plan and Budget, 2012-13 for recurring components only. Director informed the decision was taken also keeping in view large pending works sanctioned in last 3 years and pending decision to adopt State Schedule of Rates for civil works under RMSA.

- 5.3 Even though the Department has proposed application of State Schedule of Rates, raising of MMER and coverage of Govt- aided schools, on which the Planning Commission has supported, however the approval for application of these has not yet come through due to which, at present, the prevailing norms still govern RMSA activities.
- 5.4 The Director also informed the Financial Controllers that after the signing the MoU with the Developing Partners on External Funding Assistance for the RMSA programme, the States / UTs shall have to ensure sending the Interim Financial Reports (IFR) and audit reports on time which will be the basis for re- imbursements of funds. In this respect, a detailed letter has been issued to States/ UTs. Director requested the participants to follow the instructions issued.
- 5.5 She informed that following of the FMP Manual is mandatory. The Director especially mentioned adoption of e-procurement method for procurement of goods, services and works worth Rs. 50 lakhs and above. With regard to adoption of e-procurement, MHRD has organized a National level workshop and it was agreed that NIC will provide necessary support to States/ UTs. She also mentioned that Monitoring and Review of the implementation of the scheme by Monitoring Institutes which will be engaged by the MHRD will be starting soon and the States / UTs to support the same.
- 5.6 Manual on Financial Management and Procurement for RMSA is under print and the same would be made available to the States/ UTs in August 2012. The same has been put on the RMSA page of the MHRD Website and is available for downloading.
- 5.7 Committee on Papers Laid on the Table (COPLOT), Rajya Sabha has recently decided to hear the views of the Secretary, Department of School Education and Literacy and also the States representatives regarding the reasons for delay/ non-submission of Annual Report for 2009-10 and 2010-11 on the table of Parliament. She added that such delays in future may impact the release of funds under the scheme.
- 5.8 For 2012-13, since the proposal under consideration for RMSA is only for recurring components, the outlay for MMER (Management, Monitoring, Evaluation and Research) which is 2% of the outlay would be less. With this limited outlay under MMER, States/ UTs may face problem in managing the activities required to be carried out under the intervention especially the salary of the staff. Director

informed that in such a scenario and for better coordination MHRD is of the view that RMSA society and SSA Society may work in close co-ordination and a lot of resources and assets as well as activities can be used by both SSA and RMSA commonly or clubbed, for example, data collection and compilation, review meetings, workshops, awareness programmes, community mobilization programmes, etc. . She expressed the hope that the situation is likely to improve in the coming years.

6. Thereafter, State wise issues were taken up for discussion as follows:

- 7. Ms. Amita Singla, Sr. Consultant, made a presentation on the overview of progress made under RMSA. The presentation is annexed at *Annexure-C*. The highlights of the presentation are as follows:
 - 7.1 Some of the Quarterly Progress Reports for the financial year 2011-12 has not been received from 11 States: Chhattisgarh, Delhi, Goa, Haryana, Jammu &Kashmir, Kerala, Lakshadweep, Nagaland, Puducherry, Rajasthan and Sikkim. These States were requested to submit the report at the earliest. It was further informed that non receipt of these reports withholds processing of files for release of funds.
 - 7.2 In addition to this, discrepancies have been observed with respect to the reports received from 14 States. All the States were advised to avoid some common mistakes

made in the reports like expenditure reported in 2 reports are different, physical progress is not reported etc.

- 7.3 Quarterly progress report for the quarter ending June 2012 was not received from 14 States: Andaman & Nicobar, Andhra Pradesh, Arunachal Pradesh, Bihar, Delhi, Goa, Kerala, Lakshadweep, Nagaland, Orissa, Puducherry, Punjab, Rajasthan and Sikkim. All the States were requested to send their quarterly report by 20th of following month of the quarter ending and at least 2 days before the meeting for necessary compilation.
- 7.4 Expenditure analysis was presented State-wise under recurring and non recurring heads. There are 15 States where no teacher has been recruited till date. The commitment given by the States is as follows:
 - Arunachal Pradesh- Teachers will be appointed within 15 days
 - Bihar- Teachers will be in position by November 2012
 - Gujarat- Recruitment will take another 2-3 months
 - Haryana- Recruitment will take another 2-3 months
 - Jammu & Kashmir- Head masters already appointed and subject teachers will be in place in 10 days
 - Karnataka- State is in the process of re-deployment of teachers and after that recruitment will take place and by December 2012 teachers are expected to be in place
 - Meghalaya- Teachers will be recruited by January 2013
 - Uttar Pradesh- Teachers will be recruited within 2 months
 - Uttarakhand- Teachers will be recruited in 2 months time
 - Tamil Nadu- Appointment of teachers will take another 3 months time
 - Rajasthan- Teacher recruitment is in process
 - Maharashtra- It may take another 5 months time
- 7.5 Annual work plan and Budget for 2012-13 has been received from only 10 States. Rest of the States/ UTs were requested to submit the proposal at the earliest.
- 8. Ms. Ishrat Jahan, Consultant (FM), made a presentation of issues related to Audit report and Annual report. The copy of the presentation is annexed at *Annexure -D*. The highlights of the presentation are as follows:
 - 8.1 Due date for submission of audit report to MHRD is 31st August 2012.

- 8.2 Schedule as given in the FMP Manual may be followed to ensure timely preparation/ submission of audit report.
- 8.3 Annual report for 2009-10 is due for submission for the State of Arunachal Pradesh and Sikkim. Hindi version of the annual report is awaited from Nagaland. Delay Statement is pending from the State of Jharkhand, Lakshadweep and Nagaland. The States were urged to provide the pending report at the earliest so as to enable MHRD to lay it on the table of parliament during the upcoming Monsoon session.
- 8.4 The audit report for 2010-11 is due for submission from Arunachal Pradesh and Kerala. The States were requested to expedite the work for early submission of audit report. In addition to these, annual report for 2010-11 is pending from the State of AP, Arunachal Pradesh, D&DIU, Dadra & Nagar Haveli, HP, J&K, Jharkhand, Karnataka, Kerala, Lakshadweep, MP, Maharashtra, Meghalaya, Mizoram, Orissa, Puducherry, Punjab, Sikkim and West Bengal. Hindi version of the annual report is pending for the State of Nagaland.
- 9. The expenditure Statement for 2012-13 as on June 2012 was compiled and reviewed which is as under:-
 - 9.1 Expenditure for the financial year 2012-13 for the quarter ending June 2012: The expenditure Statement for 2012-13 as on 30th June 2012 was also compiled for recurring and non recurring components as annexed at *Annexure-E*. The information is still awaited from Andaman & Nicobar, Arunachal Pradesh, Delhi, Goa, Kerala, Lakshadweep, Nagaland, Puducherry, Punjab, Rajasthan and Sikkim. As per the Statements, for recurring components, against Rs. 77225.26 lakhs available, the expenditure is Rs.6222.14 lakhs (8%) and Rs. 71003.12 lakhs is the unspent balance. Under non-recurring head, Rs. 17318.78 lakhs is the expenditure reported against the available funds of Rs. 190995.70 lakhs.
 - 9.2 Release of State Share: The State wise statement on release of State share is attached at *annexure-E*. There is a shortfall in release of State Share State with respect to MHRD releases as on 30th June 2012 for State of Andhra Pradesh, Arunachal Pradesh, Assam, Himachal Pradesh, Karnataka, Manipur, Meghalaya, Mizoram, Odisha, Tripura and Uttar Pradesh. These States should ensure release of State matching share in current quarter.
 - 9.3 Activity wise progress report: The compilation of activity wise progress as on 30th June 2012 as submitted by the State is at *annexure*-F. For many States/ UTs

the expenditure reported under activity-wise report does not tally with other Statement on Financial Status.

- 9.4 Status on submission of Audit report and annual report: The Statement on status on submission of annual report for 2009-10 and audit report and annual report for 2010-11 and audit report for 2011-12 is at *annexure-G*.
- 10. In her concluding address, Director (School Education), requested all the participants to send the pending audit report and annual reports for the year 2009-10 and 2010-11 at the earliest to enable MHRD to lay it on the table of Parliament during the upcoming Parliament session. She also clarified that Annual report submission is deemed to be submitted if and only if both Hindi and English version has been submitted in 60 copies along with the delay statement (in case of delay). She also requested to submit the quarterly reports in the prescribed formats on regular basis. This also helps MHRD in timely processing of files for fund release. She thanked the participants for their active participation in the meeting.
- 11. The meeting ended with a vote of thanks to the Chair.
