

I am directed to state that the meeting of the Central Grant in-aid Committee for the scheme for Infrastructure Development Private Aided/Unaided Minority Institutes (Elementary Secondary/Senior Secondary Schools (IDMI) was held on 22.12.2014 and considered the proposals of the State Government of Uttar Pradesh. In the light of the decision of the Central Grant in Aid Committee, I am directed to convey the approval of the Government of India to the following proposal of the Government of Uttar Pradesh :-

2. In continuation of this Department's sanction order of even no. dated 13th February, 2015 releasing thereby an amount of Rs. 5,33,000/-, I am directed to convey the sanction of the President of India to the payment of central assistance (Non-recurring) of Rs. 5,33,000/- (Rs. Five Lakh and Thirty Three Thousand only) as second installment against the approved cost of the proposal amounting to Rs. 10,66,000/- (75% Central Government share) subject to the condition that the State Government would ensure that the guidelines for release of grant under IDMI Scheme are fully complied with. Thus making a total release of Rs. 10,66,000/-.

3. The expenditure involved is debitable to Demand No.59-Department of School Education and Literacy – Major Head '3601 Grants-in-Aid to State Government 02-Grants for Centrally Sponsored Plan Scheme, 165-Elementary Education, 01-The Scheme for Infrastructure Development in Minority Institutions (IDMI) 01.00.35-Grants-in-Aid Capital assets (Plan) 2015-16.

4. On receipt of the sanction letter, the Principal Accounts Officer may issue an advice to Reserve Bank of India (Central Accounts Section), Nagpur for affording credit to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and finance Department of State Government concerned along with a copy to the undersigned.
