- 2. I am, accordingly, directed to convey the sanction of the President of India to the payment of central assistance (Non-recurring) of Rs. 39,58,000/- (Rs. Thirty Nine Lakh and Fifty Eight Thousand only) as first instalment as against the approval cost of the proposals amounting of Rs. 79,14,000/- subject to the condition that the assistance is utilized in a time bound manner and the balance of 50% of the approved proposals will be released within one year of the release of first instalment during which period the 25% share of the minority institutions, should be contributed to the infrastructure upgradation. Moreover, release of next instalment of central assistance would be subject to furnishing of UCs alongwith the audited expenditure certificate.
