


I am directed to say that Government of India had approved an expenditure of Rs. 2,90,72,000/- (Rs. Two Crore Ninety Lakh and Seventy Two Thousand only) to State Government of Tripura in CGIAC meeting held on 27.8.2014 for the year 2014-15 under the Scheme for Providing Quality Education in Madarsas (SPQEM). The Grant-in-Aid is for giving assistance to **129 Madarsas (renewal)** as indicated below:-

2. In continuation of this Department's sanction letter of even no. dated 31st December, 2014 releasing thereby an amount of Rs. 145.36 Lakh, I am directed to convey the sanction of the President of India to release a sum of Rs. 1,43,36,000/- (Rs. One Crore Forty Three Lakh and Thirty Six Thousand only) to Secretary, Government of Tripura as second instalment for implementation of the above mentioned scheme for the year 2014-15 and subject to fulfilling of all terms and conditions laid down in the scheme and in terms of this Ministry's letter dated 29.10.2008. This is also subject to all Madarasas seeking financial assistance fulfill eligibility conditions as per paras 9-13 of the Scheme and all the teachers were actually engaged during 2014-15 and possess requisite qualifications. This is purely a voluntary scheme and the concerned institution has to apply to the State Government.
3. The expenditure involved is debitable to Demand No.59-Department of School Education and Literacy – Major Head '3601 Grants-in-Aid to State Government 02-Grants for State Plan Scheme, 165-Elementary Education, the Scheme for Providing education to Madrasas/Minorities 01.00.31-Grant-in-aid General (Plan) after re-appropriation from Major Head '2552' – North Eastern Areas, 00.156-Elementary Education- Other Expenditure-,10-Scheme for providing Education to Madarsas/ Minorities-00- General Component-31- Grants in aid General 2015-16.
4. It is certified that the grant in aid is being released in accordance with the pattern of assistance approved by the Planning Commission and the Ministry as also in conformity with the rules and regulations of the scheme.
5. The amount of the grant is to be utilized only for the purpose for which it was sanctioned. Accounts from the State Government to be furnished to the Central Government within one year issue of the sanction positively along with the monitoring report regarding number of Madrasas receiving assistance, total number of beneficiary students and the amounts received and utilized by the Madrasa.
6. On receipt of the sanction letter, the Principal Accounts Officer may issue an advice to Reserve Bank of India (Central Accounts Section), Nagpur for affording credit to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and finance Department of State Government concerned along with a copy to the undersigned.
7. It may also be ensured that utilization certificate in respect of this grant may be furnished as a separate and distinct set of proposal as forwarded to this Department under Scheme for Providing Quality Education in Madarsas (SPQEM).
8. No previous Utilisation Certificate is pending.


