I am, accordingly, directed to convey the sanction of the President of India to the payment of central assistance (Non-recurring) of Rs. 7,13,000/- (Rs. Seven Lakh Therteen



Thousand only) as first installment against the approved cost of the proposal amounting to Rs. 14,25,000/- (75% Central Government share) subject to the condition that the assistance is utilized in a time bound manner and the balance of 50% of the approved Central Government's share will be released within one year of the release of first installment during which period the 25% share of the minority institutions, should be contributed to the infrastructure up gradation. Moreover, release of next installment of central assistance would be subject to furnishing of UCs along with the audited expenditure certificate.
