Sir,

I am directed to say that Government of India has approved an expenditure of Rs. 2,76,29,000/- (Rs. Two Crore Seventy Six Lakh and Twenty Nine Thousand only) to State Government of Uttarakhand under the Scheme for Providing Quality Education in Madarasas (SPQEM) for the year 2014-15 in CGIAC meeting held on 22.12.2014. The Grant-in-Aid is for giving assistance to 74 Madrasas (renewal) as indicated below:-

In continuation of this Department's sanction letter of even number dated 11th February, 2015 releasing thereby an amount of Rs. 1,38,15,000/- as first instalment, I am directed to convey the sanction of the President of India to release a sum of Rs. 1,38,14,000/- (Rs. One Crore Thirty Eight Lakh and Fourteen Thousand only) as second installment to Secretary, Deptt. of Minority Welfare & Wakf Section-3, Government of Uttarakhand for implementation of the above mentioned scheme for the year 2014-15. Thus making a total of Rs. 2,76,29,000/- towards implementation of SPQEM Scheme for 2014-15 in respect of 74 Madarasas. The release is subject to fulfilling of all terms and conditions laid down in the scheme and in terms of this Ministry's letter dated 29.10.2008. This is also subject to the condition that the Madarasas seeking financial assistance fulfill eligibility conditions as per para 9-13 of the Scheme and all the teachers were actually engaged during 2013-14 and possess requisite qualification. This is a purely voluntary scheme and the concerned institution has to apply to the State Government.
3. The expenditure involved is debitable to Demand No.59-Department of School Education and Literacy – Major Head '3601 Grants-in-Aid to State Government 02-Grants for State Plan Scheme, 165-Elementary Education, the Scheme for Providing education to Madarasas/Minorities 01.00.31-Grant-in-aid General (Plan) 2015-16.
4. It is certified that the grant in aid is being released in accordance with the pattern of assistance approved by the Planning Commission and the Ministry as also in conformity with the rules and regulations of the scheme.
5. The amount of the grant is to be utilized only for the purpose for which it was sanctioned. Accounts from the State Government to be furnished to the Central Government within one year issue of the sanction positively along with the monitoring report regarding number of Madarasas receiving assistance, total number of beneficiary students and the amounts received and utilized by the Madarasas.
6. On receipt of the sanction letter, the Principal Accounts Officer may issue an advice to Reserve Bank of India (Central Accounts Section), Nagpur for affording credit to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and finance Department of State Government concerned along with a copy to the undersigned.
7. It may also be ensured that utilization certificate in respect of this grant may be furnished as a separate and distinct set of proposal as forwarded to this Department under Scheme for Providing Quality Education in Madarasas (SPQEM).
8. The grant is regarding 74 renewal Madarasas. No previous UC in respect of these Madarasas is pending.
