2. Regulation of pay and other terms of deputation: The pay of the selected candidate will be regulated under the provisions contained in the DoP&T O.M. No.6/8/2009-Estt.(Pay II) dated 17/06/2010 as amended time to time.

- 3. <u>Age-limit:</u> The maximum age-limit for appointment on deputation basis **shall not be exceeding fifty-six (56) years** as on the closing date of receipt of applications.
- **4.** Period of deputation: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/Department of the Central Government shall ordinarily not exceed three years.
- **5.** Reservation of SC/ST: No provision for reservation exists for the posts to be filled up on deputation basis.
